BEGINNING at a drill hole in the northern line of Parkwood Street, said drill hole being twenty-eight and three tenths (28.3) feet east of the northeast corner of Parkwood Street and the first alley east of Mulberry Street; thence in an easterly direction along the north line of Parkwood Street, thirty-eight and seven tenths (38.7) feet to a drill hole in the north line of Parkwood Street; thence in a northerly direction in a line parallel with the aforesaid alley, one hundred sixty (160) feet to a point in the southern line of Guinter Avenue; thence in a westerly direction along the southern line of Guinter Avenue, thirty-eight and seven tenths (38.7) feet to a point; thence in a southerly direction in a line parallel with the eastern line hereof and through the center of a party wall of a double brick dwelling one hundred sixty (160) feet to a drill hole in the north line of Parkwood Street, the point and place of beginning.
