Bella Vista Village, dated September 18, 1956, and recorded in the Office of the Recorder of Deeds in Lycoming County, Pennsylvania, in Deed Book 395, Page 427, and being more particularly bounded and described as follows:

BEGINNING at a point in the South line of Confair Parkway (50 feet wide), said point being at the intersection of the Northern line of Confair Parkway with the centerline of a 20 feet pedestrian walk, said pedestrian walk being located between Lots No. 9 and No. 10 in Block B and being 615.2 feet West of the intersection of the Southern line of Confair Parkway with the Western line of Bella Vista Road as measured along the Southern line of Confair Parkway; thence along the centerline of the said pedestrian walk South 38 degrees 4 minutes 10 seconds West 155 feet to a point; thence South 51 degrees 55 minutes 50 seconds East 90 feet to an iron pin at the Southwestern corner of Said Lot No. 11 in Block B; thence along the Western line of said Lot No. 11 in Block B, North 38 degrees 4 minutes 10 seconds East 155 feet to an iron pin in the Southern line of Confair Parkway; thence along the Southern line of Confair Parkway North 51 degrees 55 minutes 50 seconds West 90 feet to the place of beginning.
